AN ORDINANCE

EMPOWERING THE FORTY FOUR (44) BARANGAYS OF GERONA TO CORRAL AND IMPOUND ROAMING AND ASTRAY DOMESTIC ANIMALS WITHIN THEIR REPECTIVE TERRITORIAL JURISDICTIONS AND PRESCRIBING CHARGES AND PENALTIES FOR IMPOUNDING SERVICES RENDERED.

WHEREAS, Republic Act 7160, as amended mandates Local Government Units to promote health and safety and enhance the right of the people to a balanced ecology;

WHEREAS, improper and irresponsible care and protection of domesticated animals pose a grave threat to the safety and security of our communities and residents;

NOW THEREFORE, on motion of Hon. Edwin Aldrin R. Yamoyam, Chairman of the Committee on Rules, Privileges, Ordinances and Legal Matters, and duly seconded.

BE IT ENACTED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, that:

Section 1. All forty four (44) barangays of Gerona are hereby empowered to corral and impound astray and roaming domestic animals including livestock and cattles.





AN ORDINANCE

EMPOWERING THE FORTY FOUR (44) BARANGAYS OF GERONA TO CORRAL AND IMPOUND ROAMING AND ASTRAY DOMESTIC ANIMALS WITHIN THEIR REPECTIVE TERRITORIAL JURISDICTIONS AND PRESCRIBING CHARGES AND PENALTIES FOR IMPOUNDING SERVICES RENDERED.

WHEREAS, Republic Act 7160, as amended mandates Local Government Units to promote health and safety and enhance the right of the people to a balanced ecology;

WHEREAS, improper and irresponsible care and protection of domesticated animals pose a grave threat to the safety and security of our communities and residents;

NOW THEREFORE, on motion of Hon. Edwin Aldrin R. Yamoyam, Chairman of the Committee on Rules, Privileges, Ordinances and Legal Matters, and duly seconded.

BE IT ENACTED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, that:

Section 1. All forty four (44) barangays of Gerona are hereby empowered to corral and impound astray and roaming domestic animals including livestock and cattles.



Section 2. For purpose of this ordinance, the animals referred to in Section 1 shall include not only dogs, cats and other domestic pets, but also cattles, goats, carabaos and other related animals.

Section 3. All barangays of the Municipality of Gerona are hereby authorized to empower their respective committees on Peace and Order, health and to mobilize the Bantay Bayan Members to implement the provisions of this ordinance.

Section 4. All domestic animals corralled and impounded by the barangay shall be held in their custody. The Barangay Officials shall then exert all effort to know the real owner of said impounded animal/animals.

Section 5. After determining the real owner/owners of impounded animal/animals, the barangay chief executive or the barangay secretary shall properly and officially notify the owner/owners and imposed a penalty of fine and/or charged in the manner as follows:

- a. One hundred pesos (P/100.00) – for everyday impoundment of each dog, cats and other related domestic animals.
- b. Three hundred pesos (P/300.00) – for everyday impoundment of each goat, carabao, cattle and other livestock.

Section 6. When the owner/owners of such domestic animal, livestock and/or cattle fails to redeem the corralled and impounded animals within fifteen (15) days from notice, the barangay concerned is authorized to sell such corralled and impounded animals in public auction to cover the costs and expenses incurred in the corral and impounding of such animals. After the charges or penalties were collected by the barangay, the remaining amount shall be given to the owner/owners.

Section 7. For this purpose, the barangays are authorized to utilize any available open spaces in their respective territorial jurisdiction as corral and impounding areas.


Section 8. The charges or fines prescribed in this ordinance shall accrue to the general fund of the barangay to be used for the maintenance of the corral and impounding area as provided in this ordinance.

Section 9. If any provision or part hereof is held invalid or unconstitutional, the remainder of the ordinance or the provision not otherwise affected shall remain valid and subsisting.


Section 10. All ordinances, resolutions or executive orders found to be inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.



Section 6. When the owner/owners of such domestic animal, livestock and/or cattle fails to redeem the corralled and impounded animals within fifteen (15) days from notice, the barangay concerned is authorized to sell such corralled and impounded animals in public auction to cover the costs and expenses incurred in the corral and impounding of such animals. After the charges or penalties were collected by the barangay, the remaining amount shall be given to the owner/owners.

Section 7. For this purpose, the barangays are authorized to utilize any available open spaces in their respective territorial jurisdiction as corral and impounding areas.

Section 8. The charges or fines prescribed in this ordinance shall accrue to the general fund of the barangay to be used for the maintenance of the corral and impounding area as provided in this ordinance.

Section 9. If any provision or part hereof is held invalid or unconstitutional, the remainder of the ordinance or the provision not otherwise affected shall remain valid and subsisting.

Section 10. All ordinances, resolutions or executive orders found to be inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.
