AN ORDINANCE

PROHIBITING THE CHARGING OF A BAR FINE OR ANY SIMILAR PAYMENT WHICH ALLOWS A CUSTOMER TO BRING OUT A PERSONNEL/EMPLOYEE OF ANY NIGHTCLUB, BEERHOUSE, KARAOKE/SING ALONG CLUB OR OTHER SIMILAR ESTABLISHMENT IN THE MUNICIPALITY OF GERONA.

Introduced by: HON. EDWIN ALDRIN R. YAMOYAM

WHEREAS, Republic Act No. 7160 empowers the municipal council to enact ordinances intended to prevent activities inimical to the welfare and morale of the inhabitants of their municipality;

WHEREAS, it is also within the powers of this August Body to regulate the establishment, operation and maintenance of nightclubs, restaurants, beerhouses and other similar establishments;

WHEREAS, some nightclubs, beerhouses, karaoke/sing along clubs and other similar establishments are charging bar fine in order for the customers to bring out any employee/personnel working in the said establishments;


WHEREAS, prohibiting the charging of bar fine will prevent these above-mentioned establishments from becoming fronts for prostitution;







AN ORDINANCE
PROHIBITING THE CHARGING OF A BAR FINE OR ANY SIMILAR PAYMENT WHICH ALLOWS A CUSTOMER TO BRING OUT A PERSONNEL/EMPLOYEE OF ANY NIGHTCLUB, BEERHOUSE, KARAOKE/SING ALONG CLUB OR OTHER SIMILAR ESTABLISHMENT IN THE MUNICIPALITY OF GERONA.

WHEREAS, Republic Act No. 7160 empowers the municipal council to enact ordinances intended to prevent activities inimical to the welfare and morale of the inhabitants of their municipality;

WHEREAS, it is also within the powers of this August Body to regulate the establishment, operation and maintenance of nightclubs, restaurants, beerhouses and other similar establishments;

WHEREAS, some nightclubs, beerhouses, karaoke/sing along clubs and other similar establishments are charging bar fine in order for the customers to bring out any employee/personnel working in the said establishments;


WHEREAS, prohibiting the charging of bar fine will prevent these above-mentioned establishments from becoming fronts for prostitution;
