AN ORDINANCE

ENJOINING THE PLACEMENT OF STICKERS CONTAINING HOTLINE/CELLULAR PHONE NUMBERS OF THE LOCAL POLICE FOR CRIME REPORTING AND POLICE ASSISTANCE.

WHEREAS, there are times when the need to contact a law enforcer is so urgent due to an accident or crime committed but our constituents and the general public do not know the easiest way of contacting the police;

WHEREAS, to ensure that the people have easy access to the contact or hotline numbers of law enforcers, this body decided to enjoin the placement of stickers containing hotline numbers for crime reporting and police assistance,

WHEREAS, this ordinance will definitely redound to the benefit and general welfare of the entire constituency;

NOW THEREFORE, on motion of Hon. Eduardo M. Lumagui, Jr., Chairman of the Committee on Peace, Order, Public Safety, Justice and Disaster Management and duly seconded;

BE IT ENACTED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, that:

Section 1. The following are required to place stickers containing hotline telephone/cellular phone numbers of the local police for crime reporting and police assistance:

- a. All types of public transport vehicles operating within and/or traversing to and from the territorial jurisdiction of the Municipality of Gerona
- b. All night spots, bars, KTVs, videoke bars, restaurants, cafeteria and the like operating its business within the territorial jurisdiction of the Municipality of Gerona.
- c. All recreation centers such as but not limited to the following: bowling alleys, internet cafes, billiard centers, movie houses and the like operating its business within the territorial jurisdiction of the Municipality of Gerona.

- e. Bus, PUJs and tricycle terminals located within the territorial jurisdiction of the Municipality of Gerona.
- f. Public and Private schools.
- g. Government and private owned building structures.
- h. Others.

Section 2. Penalty. Violation of Section 1 hereof shall be punished, as follows:

- a. First Offense - P/500.00 fine
- b. Second Offense - P/800.00 fine
- c. Third and Succeeding Offense - P/1,000.00 fine

Section 3. Design, Printing and Distribution of the Hotline Stickers.

- a. The Local PNP shall design the standard hotline sticker.
- b. The cost of printing of the hotline sticker will be provided by the municipal government.
- c. Said stickers will be distributed for an additional fee of thirty pesos (P/30.00) upon application or renewal of business permits of business establishments and operator's permit of public utility vehicles.

Section 4. Apprehension and Disposition of Fees from Fines Paid by the Violator of this Ordinance.

- a. The power to make apprehensions shall be vested on the local PNP.
- b. All fines shall be paid to the Municipal Treasurer which shall be properly receipted and such fine shall form part of the municipal coffers.

Section 5. Repealing Clause. All ordinances, rules or regulations or parts thereof whose provisions are inconsistent with or in contrast to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 2. Penalty. Violation of Section 1 hereof shall be punished, as follows:

- a. First Offense - P/500.00 fine
- b. Second Offense - P/800.00 fine
- c. Third and Succeeding Offense - P/1,000.00 fine

Section 3. Design, Printing and Distribution of the Hotline Stickers.

- a. The Local PNP shall design the standard hotline sticker.
- b. The cost of printing of the hotline sticker will be provided by the municipal government.
- c. Said stickers will be distributed for an additional fee of thirty pesos (P/30.00) upon application or renewal of business permits of business establishments and operator's permit of public utility vehicles.

Section 4. Apprehension and Disposition of Fees from Fines Paid by the Violator of this Ordinance.

- a. The power to make apprehensions shall be vested on the local PNP.
- b. All fines shall be paid to the Municipal Treasurer which shall be properly receipted and such fine shall form part of the municipal coffers.

Section 5. Repealing Clause. All ordinances, rules or regulations or parts thereof whose provisions are inconsistent with or in contrast to the provisions of this ordinance are hereby repealed, amended or modified accordingly.
