**AN ORDER MANDATING ALL BARANGAY TREASURERS OF THE
MUNICIPALITY OF GERONA TO POST THEIR ITEMIZED MONTHLY
COLLECTIONS AND DISBURSEMENTS**

WHEREAS, under Section 513 of Republic Act 7160, otherwise known as the Local Government Code of the Philippines, "Failure by the local treasurer or the local chief accountant to post the itemized monthly collections and disbursements of the local government unit concerned within ten (10) days following the end of every month and for at least two (2) consecutive weeks at prominent places in the main office building of the local government concerned, its plaza and main street, and to publish said itemization in a newspaper of general circulation, where available, in the territorial jurisdiction of such unit, shall be punished by a fine not exceeding Five Hundred pesos (P500.00) or by imprisonment not exceeding one (1) month, or both such fine and imprisonment, at the discretion of the court".

WHEREAS, there is a need to integrate the said provision of national law in the local sphere for its better implementation and execution.

WHEREAS, there is a need to instill public transparency with regards to the itemized monthly collections and disbursements to all barangay units of the Municipality of Gerona.

NOW THEREFORE, I DENNIS NORMAN T. GO, Mayor of the Municipality Gerona, Tarlac Province, by virtue of the powers vested in me by law, promulgate the following Order;

Section 1. Mandating all barangay treasurers of the Municipality of Gerona to post their itemized monthly collections and disbursements within ten (10) days following the end of every month and for at least two (2) consecutive weeks at prominent places in the main office building of the local government concerned, its plaza and main street, and to publish said itemization in a newspaper of general circulation, where available, in the territorial jurisdiction of such unit.
