ORDINANCE NO. 391 Series of 2009

WHEREAS, this ordinance aims to eradicate the use of "dummies" by unscrupulous businessmen who can not really do any business in any where due to the lack of vital requirements like foreigners who are neither natural born or naturalized Filipino citizens.

NOW THEREFORE, on motion of Honorable Holden N. Sembrano, Chairman of the Committee on Trade, Commerce and Industry and duly seconded.

BE IT ORDAINED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, that AN ORDINANCE PROHIBITING/REGULATING THE USE OF "DUMMIES" IN ALL BUSINESS BEING OPERATED AND OR OPERATING IN THE MUNICIPALITY OF GERONA AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF, be as it is hereby enacted.

Section 1. Title. This ordinance shall be known and cited as the "antidummy" ordinance of the Municipality of Gerona, Tarlac.

Section 2. Definition of Terms.

Dummy - A person who represents another person in a transaction but who poses as acting for himself, a strawman.

Section 3. Prohibited Act. Any person who uses another person as his/her "dummies" in any business transaction and any person who allows himself/herself to be used as a dummy by a person who does not possess the necessary requirements of the law like undocumented foreigner who are neither natural born or naturalized Filipino citizens shall suffer the penalties as follows:

Any person/entity who violates this ordinance shall be fined of not more than two thousand five hundred pesos (P/2,500.00) or an imprisonment of not less than one (1) month but not more than six (6) months or both fine and imprisonment at the discretion of the honorable court.

Section 5. Dissemination. The Local Government shall be responsible for the dissemination and introduction of this ordinance.

Section 6. Separability Clause. If any provision of this ordinance shall be declared invalid or unconstitutional, such declaration shall not affect the validity of the other provisions of this ordinance not so affected.

Section 7. Effectivity Clause. This ordinance shall take effect upon approval and satisfaction of the provisions of Local Government Code of 1991 as to posting and/or publication.

Section 7. Effectivity Clause. This ordinance shall take effect upon approval and satisfaction of the provisions of Local Government Code of 1991 as to posting and/or publication.
