








**AN ORDINANCE**

**REQUIRING THE CONSTRUCTION OF AN UNDERGROUND SECONDARY STORAGE TANK OR A DOUBLE-WALLED TANK AS A CONDITION PRECEDENT FOR THE ISSUANCE OF BUSINESS PERMIT AND OTHER REGULATORY PERMITS TO ANY GASOLINE STATION WITHIN THE TERRITORIAL JURISDICTION OF GERONA IN THE STORAGE OF GASOLINE, DIESEL, FUEL AND OTHER OIL PRODUCTS AND PROVIDING PENALTIES FOR VIOLATION THEREOF.**


**WHEREAS,** some gasoline stations in Gerona have their own underground storage tank for the purpose of storing gasoline, diesel, fuel and other oil products;

**WHEREAS,** Article 2, Section 15 of the 1987 Constitution, stating that: "The state shall protect and promote the right of health of the people and instill consciousness among them;

**WHEREAS,** Chapter 1 Section 2 (a) book 1 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides: "It is hereby declared the policy of the state that the territorial and political subdivisions of the state shall enjoy genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals. Toward this end, the state shall provide for a more responsive and accountable local government structure instituted through a system of decentralization whereby Local Government Units shall be given more powers, authority, responsibilities and resources ;



**Section 3.** The Engineering Office of the Local Government Unit shall conduct an annual ocular inspection for the determination of the viability and efficiency of the underground storage tanks of gasoline stations.

**Section 4.** The underground storage tank shall be replaced every ten (10) years and the secondary storage tank every fifteen (15) years.

**Section 5.** Any resolution, ordinance, local rules or regulations which are inconsistent with the provisions of this ordinance shall be considered repealed and/or modified accordingly.

**Section 6.** Any violation of this ordinance shall be punished by a fine of not less than one thousand pesos (P/1,000.00) nor more than two thousand pesos (P/2,000.00) or by imprisonment of not less two (2) months nor more than one year or both, at the discretion of the court. If the offender is a partnership, corporation or association, the maximum penalty or two thousand pesos as fine or the maximum of one (1) year as imprisonment or both, at the discretion of the court, shall be imposed upon the manager, managing partner, president or directors thereof, for the violation of Section 2 hereof, the same shall be a ground for non-renewal of business/mayor's license/permit.

**Section 7.** This ordinance shall take effect upon approval and satisfaction of the provisions of Local Government Code of 1991 as to posting and/or publication.

**Section 3.** The Engineering Office of the Local Government Unit shall conduct an annual ocular inspection for the determination of the viability and efficiency of the underground storage tanks of gasoline stations.

**Section 4.** The underground storage tank shall be replaced every ten (10) years and the secondary storage tank every fifteen (15) years.

**Section 5.** Any resolution, ordinance, local rules or regulations which are inconsistent with the provisions of this ordinance shall be considered repealed and/or modified accordingly.

**Section 6.** Any violation of this ordinance shall be punished by a fine of not less than one thousand pesos (P/1,000.00) nor more than two thousand pesos (P/2,000.00) or by imprisonment of not less two (2) months nor more than one year or both, at the discretion of the court. If the offender is a partnership, corporation or association, the maximum penalty or two thousand pesos as fine or the maximum of one (1) year as imprisonment or both, at the discretion of the court, shall be imposed upon the manager, managing partner, president or directors thereof, for the violation of Section 2 hereof, the same shall be a ground for non-renewal of business/mayor's license/permit.

**Section 7.** This ordinance shall take effect upon approval and satisfaction of the provisions of Local Government Code of 1991 as to posting and/or publication.
