Section 4. This Executive Order shall take effect immediately.





**AN ORDER ESTABLISHING THE LOCAL VERIFICATION COMMITTEE

WHEREAS, the National Household Targeting System for Poverty Reduction (NHTS-PR), is a data management system that makes available a database of poor households as reference in identifying beneficiaries in social services.

WHEREAS, it aims to come up with a functional, objective and transparent targeting system that identifies who and where the poor are, at the same time work to address the issue of leakage or the non-poor being included and unfair deprivation or the poor being excluded as beneficiaries of social protection programs and services.

WHEREAS, the NHTS-PR system uses a paper and pencil approach for data gathering. Data is then encoded into the system and a statistical formula calculates the household's approximate income that allows for objective ranking, classification and prioritization of households.

NOW THEREFORE, I DENNIS NORMAN T. GO, Mayor of the Municipality Gerona, Tarlac Province, by virtue of the powers vested in me by law, promulgate an order establishing the Local Verification Committee for the NHTSRP Program of DSWD in the Municipality of Gerona.
