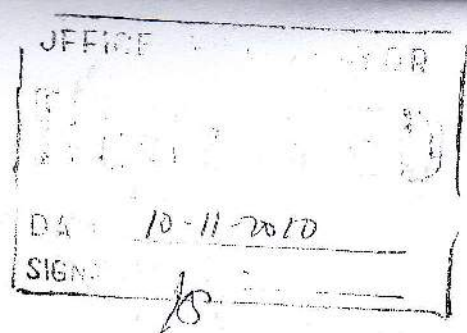

Ignacia, Tarlac Provincial Road is the shortest route linking the provinces of Nueva Ecija, Tarlac and Pangasinan and can be considered as vital to their development as it directly connects Pan-Phil Highway, the gateway to Northeastern Luzon and Romulo Highway, the gateway to Southeastern Luzon, passing through MacArthur Highway that connects to North Luzon Expressway (NLEX) and Subic, Clark, Tarlac Expressway (SCTEX) where the Tagumbao Bridge is a component part;

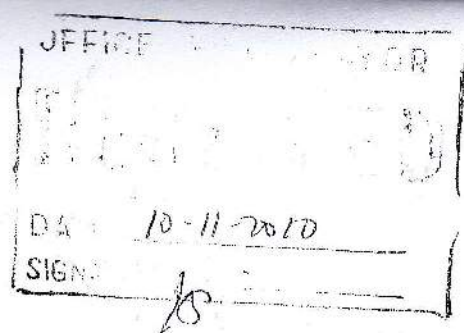
