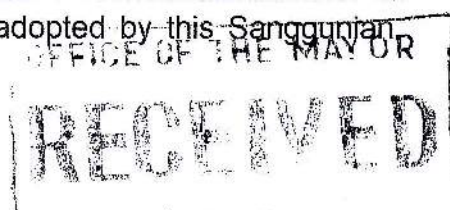
NOW THEREFORE on motion of Hon. Fred R. Isla, Chairman of the Committee on Education, Culture and Tourism and duly seconded.

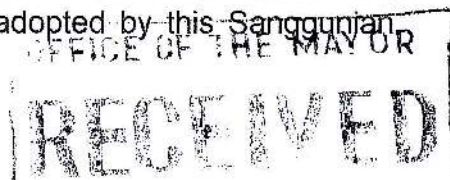




