**NOW THEREFORE**, on motion of Hon. Eufrocino A. Bartolome, Jr., Chairman of the Committee on Public Works, Housing, Transportation and Communications, duly seconded, and unanimously approved;

**BE IT ENACTED** by this Sangguniang Bayan in session assembled that:

**Section 1.** Sub par 9, Section 10 of Ordinance No. 272, Series of 1999 as amended by Ordinance No. 331, Series of 2005, Ordinance No. 366, Series of 2008 and Ordinance No. 382, Series of 2008 is hereby further amended to read as follows:

The fare structure for tricycles-for-hire shall be as follows:

- a. **For Regular Commuters:** Nine pesos (P/9.00) minimum fare for the first kilometer and one peso (P/1.00) for every succeeding kilometer thereafter or a major fraction hereof.
- b. **For Students.** Seven pesos (P/7.00) minimum fare for the first kilometer and one peso (P1.00) for every succeeding kilometer thereafter or major fraction thereof.

A 20% discount shall be extended to all qualified senior citizens upon presentation of a Senior Citizen's Identification Card.

**Section 2.** Should fuel prices decrease by an average of twenty percent (20%) from the prevailing rate, the Sangguniang Bayan, through the Municipal Tricycle Franchising and Regulatory Board (MTFRB), may reduce tricycle fares correspondingly without need of a public hearing.

**Section 3.** Operators and drivers of tricycles-for-hire shall first secure a matrix or schedule of fares from the MTFRB upon payment of a fee of ten pesos (P/10.00) before they can charge the new fare structure.

The matrix shall be posted prominently in all tricycles-for-hire in full view of the commuters.

**Section 4.** All other provisions of Municipal Ordinance No. 272, Series of 1999 as amended, shall remain in full force and effect.







**NOW THEREFORE**, on motion of Hon. Eufrocino A. Bartolome, Jr., Chairman of the Committee on Public Works, Housing, Transportation and Communications, duly seconded, and unanimously approved;

**BE IT ENACTED** by this Sangguniang Bayan in session assembled that:

**Section 1.** Sub par 9, Section 10 of Ordinance No. 272, Series of 1999 as amended by Ordinance No. 331, Series of 2005, Ordinance No. 366, Series of 2008 and Ordinance No. 382, Series of 2008 is hereby further amended to read as follows:

The fare structure for tricycles-for-hire shall be as follows:

- a. **For Regular Commuters:** Nine pesos (P/9.00) minimum fare for the first kilometer and one peso (P/1.00) for every succeeding kilometer thereafter or a major fraction hereof.
- b. **For Students.** Seven pesos (P/7.00) minimum fare for the first kilometer and one peso (P1.00) for every succeeding kilometer thereafter or major fraction thereof.

A 20% discount shall be extended to all qualified senior citizens upon presentation of a Senior Citizen's Identification Card.

**Section 2.** Should fuel prices decrease by an average of twenty percent (20%) from the prevailing rate, the Sangguniang Bayan, through the Municipal Tricycle Franchising and Regulatory Board (MTFRB), may reduce tricycle fares correspondingly without need of a public hearing.

**Section 3.** Operators and drivers of tricycles-for-hire shall first secure a matrix or schedule of fares from the MTFRB upon payment of a fee of ten pesos (P/10.00) before they can charge the new fare structure.

The matrix shall be posted prominently in all tricycles-for-hire in full view of the commuters.

**Section 4.** All other provisions of Municipal Ordinance No. 272, Series of 1999 as amended, shall remain in full force and effect.
