## **ORDINANCE NO. 441**

Series of 2014

Introduced by: HON. ELOY C. ECLAR

#### **AN ORDINANCE**

REGULATING THE LOADING AND UNLOADING AREA ALONG THE MAJOR INTERSECTION (CROSSING) OF MANILA NORTH ROAD (aka NAM-KWANG ROAD) AND GERONA-PURA PROVINCIAL ROAD, PROVIDING PENALTIES FOR VIOLATORS THEREOF AND FOR OTHER PURPOSES.

**WHEREAS**, Manila North Road (aka Nam Kwang Road) has recently undergone road widening to accommodate the growing volume of vehicles, to prevent congestion and ensure the smooth flow of traffic. However, due to unregulated vehicular activities like loading, unloading and parking near the major intersection with Gerona-Pura Provincial Road, that purpose was slowly being defeated.

**WHEREAS**, to protect lives and properties caused by vehicular accidents, unregulated vehicular activities, there is a need to pass an ordinance regulating the loading and unloading area along the major intersection (crossing) of Manila North Road (aka Nam Kwang Road) and Gerona-Pura Provincial Road, providing penalties for violators thereof and for other purposes.

**NOW THEREFORE**, on motion of Honorable Eloy C. Eclar, Chairman of the Committee on Public Works, Housing, Transportation and Communications and duly seconded

**BE IT ORDAINED** by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, that:

Section 1. Short Title. This ordinance shall be known and cited as "LOADING AND UNLOADING ORDINANCE OF MANILA NORTH ROAD (aka NAM KWANG) and GERONA-PURA PROVINCIAL ROAD".

**Section 2. Definition and Identification of Terms.** As used in this ordinance, the following terms shall mean:

Manila North Road – aka Nam Kwang Road. The diversion road along Mac Arthur Highway connecting Barangays San Antonio on the South, Magaspac on the North, Abagon on the East and Poblacion 03 on the West.

Gerona-Pura Provincial Road – The road that crosses the Manila North Road in Barangays Abagon and Poblacion 03.

### Section 3. Prohibited Acts.

- No loading or unloading of passengers or cargoes along Manila North Road, one hundred meters (100 mts.) from the centerline of Gerona-Pura Provincial Road on both directions and on both sides of the road from 7:00 A.M. to 7:00 P.M.
- 2. No loading or unloading of passengers or cargoes, fifty meters (50 mts.) along Gerona-Pura Provincial Road from the centerline of Manila North Road on both directions and on both sides of the road from 7:00 A.M. to 7:00 P.M.
- 3. Parking is not allowed within the designated no loading and unloading areas at anytime.

**Section 4. Penal Provision.** Violators of the above prohibited acts shall be meted the following penalties:

First Offense - Fine of one hundred pesos (P/100.00)
Second Offense - Fine of two hundred pesos (P/200.00)
Third and Succeeding Offenses - Fine of one thousand pesos (P/1,000.00)

**Section 5. Separability Clause.** If, for any reason, any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue to be in full legal force and effect.

**Section6.** Repealing Clause. All existing ordinances that are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

**Section 7.** *Effectivity.* This ordinance shall take effect immediately upon approval and satisfaction of the provisions of RA 7160 as to posting and publication.
