**A RESOLUTION**

**AUTHORIZING THE HONORABLE DENNIS NORMAN T. GO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH NATIONAL FOOD AUTHORITY (NFA), REPRESENTED BY ITS PROVINCIAL MANAGER, MS. MARIETTA J. ABLAZA, REGARDING THE PREMIUM INCENTIVE AND RICE ASSISTANCE (PRICE) PROGRAM TO PROVIDE A PREMIUM PRICE OF AT LEAST P/1.00/KG OR AN AMOUNT DETERMINED BY THE LOCAL GOVERNMENT UNIT USING AS REFERENCE THE PREVAILING MARKET PRICE TO BE ADDED TO THE EXISTING SUPPORT PRICE FOR THE PURCHASE OF PALAY FROM FARMER ORGANIZATIONS/FARMERS COOPERATIVE (FOs/FCs) IN THE MUNICIPALITY.**

On motion of Hon. Agerico S. Batenga, Chairman of the Committee on Rules, Privileges, Ordinances and Legal Matters and duly seconded.

**BE IT RESOLVED** by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, to authorize the Honorable Dennis Norman T. Go, Municipal Mayor, to enter into a Memorandum of Agreement with National Food Authority (NFA), represented by its provincial Manager, Ms. Marietta J. Ablaza, regarding the Premium Incentive And Rice Assistance (PRICE) Program to provide a premium price of at least P/1.00/kg or an amount determined by the local government unit using as reference the prevailing market price to be added to the existing support price for the purchase of palay from Farmer Organizations/Farmers Cooperative (FOs/FCs) in the municipality.

**RESOLVED FURTHER**, that the Memorandum of Agreement is deemed ratified by this Sanggunian.

**RESOLVED FINALLY**, that a copy of this resolution be duly furnished the Honorable Dennis Norman T. Go, Municipal Mayor, for his information and appropriate action.
