A RESOLUTION

AUTHORIZING THE HONORABLE DENNIS NORMAN T. GO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), REGIONAL OFFICE III, REPRESENTED BY ITS REGIONAL DIRECTOR ATTY. ANA C. DIONE, CPA FOR THE IMPLEMENTATION OF “TULONG HANAPBUHAY SA ATING DISPLACED WORKERS/DISADVANTAGED (TUPAD) WORKERS PROGRAM”.

WHEREAS, the Department of Labor and Employment (DOLE) provides assistance to help displaced or “to be” displaced workers and the unemployed poor in coping with the closure or slowing down of operations of companies, as result of economic disruptions and/or the occurrence of natural disasters, calamities, or armed conflicts that affect their economic base under its **TULONG HANAPBUHAY SA ATING DISPLACED WORKERS/DISADVANTAGED (TUPAD) WORKERS PROGRAM**.

WHEREAS, the Department of Labor and Employment Regional Office No. III (DOLE-RO III) has been given the responsibility to implement emergency employment under the TUPAD Program to enable the displaced workers due to economic crisis, natural calamities and armed conflicts to engage in short-term community works to provide them with temporary wage employment for a period of fifteen (15) days.

NOW THEREFORE, on motion of Hon. Agerico S. Batenga, Chairman of the Committee on Rules, Privileges, Ordinances and Legal Matters and duly seconded.

BE IT RESOLVED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, to authorize the Honorable Dennis Norman T. Go, Municipal Mayor, to enter into a Memorandum of Agreement with the Department of Labor and Employment (DOLE), Regional Office III, represented by its Regional Director Atty. Ana C. Dione, CPA for the implementation of *“TULONG HANAPBUHAY SA ATING DISPLACED WORKERS/DISADVANTAGED (TUPAD) WORKERS PROGRAM”*.

RESOLVED FURTHER, that the Memorandum of Agreement is deemed ratified by this Sanggunian.

RESOLVED FURTHER, that a copy of this resolution be duly furnished the Honorable Dennis Norman T. Go, Municipal Mayor, for his information and appropriate action.
