A RESOLUTION

INTENDED FOR POBLACION 01 BARANGAY PLAZA AND TWO HUNDRED TWENTY SQUARE METERS (220 SQ. M.) FOR BARANGAY CHAPEL, WITH TCT NO. 426425, LOCATED AT POBLACION 01, GERONA, TARLAC DONATED TO THE MUNICIPALITY BY THE ESTATE OF ANTONIO G. PAPA AND LUCITA M. OPLE, FOR THE PURPOSE.
