A RESOLUTION

AUTHORIZING THE HONORABLE DENNIS NORMAN T. GO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PAG-IBIG FUND (HOME DEVELOPMENT MUTUAL FUND), REGARDING THE EMPLOYER'S ACCREDITATION PROGRAM (EAP) WHICH AIMS TO PROVIDE HOUSING SUPPORT SERVICES TO EMPLOYEES AND ALSO TO ENTER INTO A COLLECTION SERVICE AGREEMENT THROUGH PAYROLL DEDUCTION UNDER ITS PAG-IBIG HOUSING LOAN PROGRAM (PHLP).

WHEREAS, Pag-Ibig Fund is one of the premier financial institutions in the country mandated to establish, develop, promote and integrate a nationwide mutual provident savings system suitable to the needs of the employed and other earning groups, and to motivate them to better plan and provide for their housing needs by becoming qualified members of the Pag-Ibig Fund, with mandatory contributory support of the employers in the spirit of social justice and the pursuit of national development.

NOW THEREFORE, on motion of Hon. Agerico S. Batenga, Chairman of the Committee on Rules, Privileges, Ordinances and Legal matters and duly seconded.

BE IT RESOLVED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, to authorize The Honorable Dennis Norman T. Go, Municipal Mayor, to enter into a Memorandum of Agreement with Pag-Ibig Fund (Home Development Mutual Fund), regarding the Employer's Accreditation Program (EAP) which aims to provide housing support services to employees and also to enter into a Collection Service Agreement through payroll deduction under its Pag-Ibig Housing Loan Program (Phlp).
