A RESOLUTION

AUTHORIZING THE HONORABLE DENNIS NORMAN T. GO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COUNCIL, REPRESENTED BY ITS EXECUTIVE DIRECTOR DR. TERESITA G. INCIONG, FOR THE CONSTRUCTION OF NATIONAL CHILD DEVELOPMENT CENTER (NCDC) LOCATED AT DAY CARE CENTER OF BARANGAY NEW SALEM, GERONA, TARLAC.

WHEREAS, the ECCD Council is duly mandated in accordance with Republic Act 10410 (Early Years Act) to institutionalize a National System for Early Childhood Care and Development (ECCD) that is comprehensive, integrative and sustainable that will involve multi-sectoral and inter-agency collaboration at the national and local levels to promote the optimum growth and development of Filipino children ages zero (0) to four (4) years;

WHEREAS, in pursuance of the above mandate, the ECCD Council aims to further enhance the provision of quality home-based and center-based ECCD Programs in partnership of stakeholders;

WHEREAS, the ECCD Council intends to establish National Child Development Centers (NCDC's) including the provision of contents and teacher to serve as its laboratory of the different modes of delivery of center-based ECCD programs;

WHEREAS, as a stakeholder, the Local Government Unit of Gerona will support the establishment and operations of a National Child Development Center (NCDC) in its jurisdiction;

NOW THEREFORE, on motion of Hon. Agerico S. Batenga, Chairman of the Committee on Rules, Privileges, Ordinances and Legal Matters and duly seconded.

BE IT RESOLVED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, to authorize the Honorable Dennis Norman T. Go, Municipal Mayor, to enter into a Memorandum of Agreement with the Early Childhood Care and Development (ECCD) Council, represented by its Executive Director Dr. Teresita G. Inciong, for the construction of National Child Development Center (NCDC) located at Day Care Center of Barangay New Salem, Gerona, Tarlac.

RESOLVED FURTHER, that the Memorandum of Agreement is deemed ratified by this Sanggunian.

RESOLVED FINALLY, that a copy of this resolution be duly forwarded to the Honorable Dennis Norman T. Go, Municipal Mayor, for his information and appropriate action.
