RESPECTFULLY REQUESTING THE DEPARTMENT OF TRANSPORTATION AND COMMUNICATIONS (DOTC) TO OPEN A ROUTE FOR UV EXPRESS TRANSPORTATION SERVICE (AIR-CONDITIONED VANS), FROM THE MUNICIPALITY OF STA. IGNACIA TO SM TARLAC CITY VIA NEW SALEM-SULIPA-GERONA, THROUGH TAGUMBAO BRIDGE.

WHEREAS, the Tagumbao Bridge in the Municipality of Gerona has been completed, connecting the thirteen (13) western barangays and creating a direct link to the western municipalities of Tarlac, all the way to western part of the Province of Pangasinan;

WHEREAS, these developments necessitates the opening of a route to spur economic activities in the area and to cater to the needs of our constituents in the said western barangays for growth and development;

NOW THEREFORE, on joint motion of Hon. Eloy C. Eclar, Chairman of the Committee on Public Works, Housing, Transportation and Communications and Hon. Agerico S. Batenga, Chairman of the Committee on Rules, Privileges, Ordinances and Legal Matters, duly seconded.

BE IT RESOLVED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, to respectfully request the Department of Transportation and Communications (DOTC) to open a route for UV Express Transportation Service (air-conditioned vans), from the Municipality of Sta. Ignacia to SM Tarlac City via New Salem-Sulipa-Gerona, through Tagumbao Bridge.
