**WHEREAS**, in the light of the foregoing circumstances, the grieving relatives of the deceased were forced to buy burial place at private cemetery even to the extent of loaning/mortgaging with high interest just to have a decent burial;

**WHEREAS**, death has its high cost indeed for the surviving heirs has to shoulder the onerous price of the funeral services and the exorbitant cost of one's final resting place;

**WHEREAS**, the Municipal Government of Gerona must look with compassion into those residents of this municipality who cannot afford to buy burial lots at private cemeteries;
