A RESOLUTION

REQUESTING THE CHIEF OF POLICE OF GERONA TO ASSIGN AT LEAST TWO (2) UNIFORMED PERSONNEL TO MONITOR THE ACTIVITIES OF ALL INTERNET SHOPS TO ENSURE THE PROPER IMPLEMENTATION OF ORDINANCE NO. 357, SERIES OF 2007, ENTITLED: "AN ORDINANCE PROHIBITING THE PLAYING OF ANY KIND OF VIDEO GAMES AND OTHER SIMILAR ITEMS FOUND IN AMUSEMENT CENTERS AND OTHER SIMILAR ESTABLISHMENTS LOCATED IN GERONA BY CHILDREN BELOW EIGHTEEN (18) YEARS OF AGE FROM 8:00 A.M. TO 11:30 A.M. AND FROM 1:00 P.M. TO 5:00 P.M., MONDAYS TO FRIDAYS AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

WHEREAS, despite the enactment of Ordinance No. 357, Series of 2007, it has been reported by many concerned citizens of Gerona that the owners and managers of some internet shops continue to allow children below eighteen (18) years of age, particularly students to play violent and sometimes highly immoral video-games not rated for their young age and worse during school hours;

WHEREAS, many high school and even elementary students are currently addicted-in and hard to contain from playing the above mentioned video games thereby neglecting their studies and wasting their money hard-earned by their respective parents;

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Bayan of Gerona in session assembled to request, as it does hereby request, the Chief of Police of Gerona to assign at least two (2) uniformed personnel to monitor the activities of all internet shops to ensure the proper implementation of Ordinance No. 357, Series of 2007, entitled: "An ordinance prohibiting the playing of any kind of video games and other similar items found in amusement centers and other similar establishments located in Gerona by children below eighteen (18) years of age from 8:00 a.m. to 11:30 a.m. and from 1:00 p.m. to 5:00 p.m., Mondays to Fridays and providing penalties for violation thereof."

RESOLVED FURTHER, to direct the Secretary to the Sanggunian to provide PSupt. Ariel R. Red, PNP Chief of Gerona with a copy of this resolution for his information and appropriate action.
