**A RESOLUTION**

**AUTHORIZING THE HONORABLE DENNIS NORMAN T. GO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), REPRESENTED BY ITS REGIONAL DIRECTOR ANTONIO V. MOLANO, JR., FOR THE CONSTRUCTION OF CONCRETE LINED CANAL ALONG MACARTHUR HIGHWAY, MANILA-NORTH-ROAD (MNR), GERONA, TARLAC SECTION, AMOUNTING TO FOUR MILLION SIX HUNDRED SIXTY THOUSAND PESOS (P/4,660,000.00).**

**WHEREAS**, the objective of this agreement is to put in effect the collaborative effort among government agencies specifically, the DPWH and LGU of Gerona, Tarlac, in providing support services to the Department of Public Works and Highways and its adjoining areas;

**WHEREAS**, the LGU of Gerona, Tarlac, signify to be in-charge of implementing the construction of concrete lined canal along MacArthur Highway (MNR), Gerona, Tarlac Section, which can serve a greater number of its constituents;

**WHEREAS**, the LGU of Gerona, Tarlac, shall be responsible for the construction of the concrete lined canal after its turn-over from DPWH, for the former to have a sense of ownership of this project;

**WHEREAS**, the DPWH shall provide the amount of four million six hundred sixty thousand pesos (P/4,660,000.00) for the implementation of the construction of the said project;

**NOW THEREFORE**, on motion of Hon. Agerico S. Batenga, Chairman of the Committee on Rules, Privileges, Ordinances and Legal Matters and duly seconded.

**BE IT RESOLVED** by this Sangguniang Bayan in session assembled, to authorize the Honorable Dennis Norman T. Go, Municipal Mayor, to enter into a Memorandum of Agreement with Department of Public Works and Highways (DPWH), represented by its Regional Director Antonio V. Molano, Jr., for the construction of concrete lined canal along Macarthur Highway, Manila-North-Road (MNR), Gerona, Tarlac Section, amounting to four million six hundred sixty thousand pesos (P/4,660,000.00).

**RESOLVED FURTHER**, that the Memorandum of Agreement is deemed ratified by this Sanggunian.

**RESOLVED FINALLY**, that a copy of this resolution be duly furnished the Honorable Dennis Norman T. Go, Municipal Mayor, for his information and appropriate action.
