**A RESOLUTION**

**APPROVING THE BARANGAY APPROPRIATIONS ORDINANCE ON ANNUAL BUDGET FOR CALENDAR YEAR 2014 OF BARANGAY CARBONEL, THIS MUNICIPALITY.**

**WHEREAS**, Sangguniang Barangay of Carbonel of this municipality submitted their duly enacted Appropriations Ordinance on Annual Budget for calendar year 2014 for review by the Sangguniang Bayan amounting to one million ninety seven thousand seven hundred twenty four pesos (P/1,097,724.00).

**WHEREAS**, based on the review of the Local Finance Committee (LFC) the said budget was found to have substantially complied with the provisions of RA 7160 (The Local Government Code of 1991) and existing standards and guidelines issued by the DBM. Thus the Committee recommended the approval of the said budget.

**WHEREAS**, after thorough deliberation, discussion and evaluation and acting on the favorable recommendation of the Local Finance Committee, on motion of Hon. Daisy Diamsay-Mamba, Chairperson of the Committee on Finance Budget and Appropriations and duly seconded.

**BE IT RESOLVED** by this Sangguniang Bayan of Gerona, Tarlac in session assembled, to approve the Annual Budget for Calendar Year 2014 of Barangay Carbonel of this municipality, subject to full compliance with the recommendation and conditions imposed by the Local Finance Committee, that allocation of funds for Solid Waste Management be provided as per RA 9003 in their EDF.

**RESOLVED FURTHER**, should the quarterly revenue targets of the barangays suffer deficits, the Punong Barangay, in consultation with the Barangay Council, shall institute mandatory savings from Maintenance and Other Operating Expenses (MOOE) and Capital Outlay Expenditures corresponding to the percentages of shortfall on the said quarter.

**RESOLVED FURTHERMORE**, that the appropriations authorized shall be disbursed strictly in accordance with the purpose for which they are intended and subject to the usual accounting and auditing rules and regulations and compliance thereof shall be the responsibility of the barangay.

**RESOLVED FINALLY**, that a copy of this resolution be duly furnished all agencies and parties concerned for their information and perusal.
