A RESOLUTION

AUTHORIZING THE HONORABLE DENNIS NORMAN T. GO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), RFU-III, REPRESENTED BY ITS REGIONAL DIRECTOR ADELINA S. APOSTOL FOR THE SUPPLEMENTAL FEEDING IN DAY CARE IN THE MUNICIPALITY.

WHEREAS, most recent data from the 7th National Nutrition Survey conducted by the Food and Nutrition Research Institute of the Department of Science and Technology revealed that prevalence of under and over nutrition still persists among Filipino children and has significantly increased as compared to the last survey.

WHEREAS, the Department of Social Welfare and Development, in its mandate to provide social welfare and development programs, particularly through technical assistance and resource augmentation, is providing nutrition services to its client at the local level through the center based community services under the Protective Services Bureau.

NOW THEREFORE, on motion of Hon. Agerico S. Batenga, Chairman of the Committee on Rules, Privileges, Ordinances and Legal Matters and duly seconded.

BE IT RESOLVED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, to authorized the Honorable Dennis Norman T. Go, Municipal Mayor, to enter into a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD), RFU-III, represented by its Regional Director Adelina S. Apostol for supplemental feeding in day care in the municipality.
