A RESOLUTION

AUTHORIZING THE HONORABLE DENNIS NORMAN T. GO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE PROCESO J. ALCALA, SECRETARY OF THE DEPARTMENT OF AGRICULTURE, THROUGH DR. ANDREW D. VILLACORTA, REGIONAL EXECUTIVE DIRECTOR, RFU-III, TO TRANSFER THE FUNDS TO THE LOCAL GOVERNMENT UNIT OF GERONA AMOUNTING TO THIRTEEN MILLION FORTY THOUSAND PESOS (P/13,040,000.00) FOR THE CONCRETING OF FARM-TO-MARKET-ROAD OF BARANGAY RIZAL, GERONA, TARLAC.
