A RESOLUTION

AFFIRMING THE VALIDITY OF SUPPLEMENTAL APPROPRIATIONS ORDINANCE NO. 01, SERIES OF 2014 OF SANGGUNIANG BARANGAY OF SAN JOSE OF THIS MUNICIPALITY.

WHEREAS, Sangguniang Barangay of San Jose of this municipality, passed a supplemental appropriations ordinance for approval of this August Body for the realignment of fund amounting to one hundred thirty thousand pesos (P/130,000.00) from the funding of purchase of lot for solar dryer to finance the pakyaw labor for the construction of barangay plaza amounting to seventy five thousand pesos (P/75,000.00), repair of boundary marker amounting to twenty thousand pesos (P/20,000.00), maintenance of streetlights amounting to twenty thousand pesos (P/20,000.00) and additional support fund for day care center amounting to fifteen thousand pesos (P/15,000.00).
