A RESOLUTION

SUPPLEMENTING THE ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY FOR CY 2014, TO INCLUDE CONSTRUCTION OF FENCE AND GATE AT THE MUNICIPAL SLAUGHTER HOUSE, AMOUNTING TO ONE HUNDRED THIRTY FIVE THOUSAND PESOS (P/135,000.00), CONSTRUCTION OF DRAINAGE AT BARANGAY POBLACION 02, AMOUNTING TO SIXTY THOUSAND PESOS (P/60,000.00), CONSTRUCTION OF BARANGAY PLAZA PAVEMENT AT BARANGAY STA. LUCIA, AMOUNTING TO SEVENTY FOUR THOUSAND PESOS (P/74,000.00) AND CONSTRUCTION OF MARKET MID AISLE AT GERONA PUBLIC MARKET, AMOUNTING TO FOUR HUNDRED SIXTY THOUSAND PESOS (P/460,000.00).

Lucia, amounting to seventy four thousand pesos (P/74,000.00) and construction of market mid aisle at Gerona Public Market, amounting to four hundred sixty thousand pesos (P/460,000.00).
