A RESOLUTION

SUPPLEMENTING THE ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY FOR CY 2014, TO INCLUDE PURCHASE OF DUMP TRUCK, AMOUNTING TO TWO MILLION PESOS (P/2,000,000.00), PURCHASE OF EMERGENCY RESCUE VEHICLE, AMOUNTING TO ONE MILLION TWO HUNDRED THOUSAND PESOS (P/1,200,000.00), MAINTENANCE OF AGROMET WEATHER STATION, AMOUNTING TO ONE HUNDRED SIXTY THOUSAND PESOS (P/160,000.00), COUNTERPART FOR THE PURCHASE OF FIRE TRUCK AMOUNTING TO THREE HUNDRED THOUSAND PESOS (P/300,000.00), ENGINEERING INTERVENTION/REPAIR OF CRITICAL INFRASTRUCTURE AMOUNTING TO SIX HUNDRED FOUR THOUSAND EIGHT HUNDRED ONE PESOS AND ONE CENTAVO (P/604,801.01) AND QUICK RESPONSE FUND AMOUNTING TO SEVEN THOUSAND TWENTY THREE PESOS AND FORTY FOUR CENTAVOS (P/7,023.44).

BE IT RESOLVED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, to supplement the Annual Investment Plan of the municipality for CY 2014 to include purchase of dump truck, amounting to two million pesos (P/2,000,000.00), purchase of emergency rescue vehicle, amounting to one million two hundred thousand pesos (P/1,200,000.00), maintenance of Agromet Weather Station, amounting to one hundred sixty thousand pesos (P/160,000.00), counterpart for the purchase of fire truck amounting to three hundred thousand pesos (P/300,000.00), engineering intervention/repair of critical infrastructure amounting to six hundred four thousand eight hundred one pesos and one centavo (P/604,801.01) and Quick Response Fund amounting to seven thousand twenty three pesos and forty four centavos (P/7,023.44).
