A RESOLUTION

AUTHORIZING THE HONORABLE DENNIS NORMAN T. GO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BARANGAY GOVERNMENT OF CALAYAAN AND SARILAYA (KASARIAN-KALAYAAN), INC. REGARDING THE ASSESSMENT AND RESOLVING THE WATER SUPPLY SANITATION AND HYGIENE (WASH).

WHEREAS, SARILAYA, as part of its mission to promote integrated health development through sustainable agriculture and nutrition-based preventive health based on organic farming and herbal gardening in Luzon as elsewhere in the country, proposes to continue and upscale its assistance to Barangay Calayaan with full support from the Gerona Municipal Government in keeping with its legislative codes covering environmental, gender and development concerns among others;

WHEREAS, the Gerona Municipal Government has expressed willingness to enter into partnership with SARILAYA in assisting Barangay Calayan in assessing and resolving the water supply, sanitation and hygiene (WASH) situation with the help of the Philippine Center for Water and Sanitation-ITN Foundation by undertaking the proposed participatory water and sanitation resources inventory and assessment (PWSRIA) with the participation of the Calayaan community as a first step leading to more permanent and lasting resolution of such issues and concerns;

NOW THEREFORE, on motion of Hon. Agerico S. Batenga, Chairman of the Committee on Rules, Privileges, Ordinances and Legal Matters and duly seconded.

BE IT RESOLVED by the Sangguniang Bayan of Gerona, Tarlac, in session assembled, to authorize The Honorable Dennis Norman T. Go, Municipal Mayor, to enter into a Memorandum of Agreement with the Barangay Government of Calayaan and SARILAYA (Kasarian-Kalayaan), Inc. regarding the assessment and resolving the water supply sanitation and hygiene (wash).

RESOLVED FURTHER, that the Memorandum of Agreement is deemed ratified by this Sanggunian.

RESOLVED FINALLY, that a copy of this resolution be duly furnished the Honorable Dennis Norman T. Go, Municipal Mayor, for his information and appropriate action.
