**A RESOLUTION**

**WHEREAS**, Sangguniang Barangay of Pinasling of this municipality, passed a supplemental appropriations ordinance for approval of this August Body for the appropriation of fund amounting to one hundred thousand seven hundred forty five pesos and sixty two centavos (P/100,745.62) from the un-appropriated fund of CY 2013 and the amount of one hundred nine thousand six hundred ninety nine pesos and ninety three centavos (P/109,699.93) from the savings of 20% Development Fund of CY 2013, with a total amount of two hundred ten thousand four hundred forty five pesos and fifty five centavos (P/210,445.55) for the Development Projects of the barangay.
